Dear Member,

The unions and guilds in BC's film industry are used to working together to develop and promote a world class workforce which consistently delivers some of the best productions seen by audiences everywhere. Now, when the coronavirus pandemic has brought an unprecedented challenge to our industry, our solidarity is more important than ever before.

In the weeks after the industry shut down, we worked together to share knowledge about payment and assistance programs available for members as those programs were being announced and often modified. We advocated on your behalf for additional compensation from governments and employers where we found gaps in coverage. We also reviewed our health plans and worked with plan trustees to enact changes to cover members during the industry stoppage. Our focus has now shifted towards planning for a safe return to work when the conditions are right. As always, our first concern is your safety and health, and that of your loved ones.

We are working with industry groups, both locally, nationally, and internationally, to develop safe working guidelines and practices for BC's motion picture industry in the age of COVID-19. There are sure to be many changes expected from everyone in the workplace, and we will all need to work together to ensure a safe working environment. Although British Columbia has fared comparatively well in our response to the crisis, treatments and vaccines are still in the developmental stage, and the virus is far from being eliminated. We don't know when the industry will ramp up again, but when it does, we will have to be careful throughout our work days as well as in our personal lives.

In the meantime, we urge everyone to follow the guidance from the BC Centre for Disease Control and other government authorities in your area. This includes practicing rigorous sanitation efforts and abiding by the
